## Reference: Notice of East Center Street Road Closure at 1<sup>st</sup> Street SE beginning May 30, 2023 Notice of 2<sup>nd</sup> Avenue SE Road Closure at 7<sup>th</sup> Street SE / Timberline Drive on June 6, 2023 Oronoco Wastewater Treatment, Sewer Collection System & Water Distribution Project

 A roadway closure of East Center Street at 1st Avenue SE will begin on Tuesday, May 30<sup>th</sup> and will last until mid-June. The road closure is necessary to allow for the installation of trunk sanitary sewer main under East Center Street from 1<sup>st</sup> Avenue SE to 2<sup>nd</sup> Avenue SE. East Center Street will be closed 7:00 AM and 7:00 PM (Monday through Saturday). The contractor will reopen the roadway during non-working hours and on Sunday with a temporary gravel reclaim surface. Please use caution in and around the construction zone.

A temporary road connecting 1<sup>st</sup> Street SE and East Center Street (west of 2<sup>nd</sup> Avenue SE) has been provided and will remain in use until precluded by sanitary sewer construction on East Center Street. The temporary road will only serve residents living along 1<sup>st</sup> Street SE.

During the East Center Street roadway closure, residents are asked to detour around the construction and enter / exist Oronoco via CR 12 / White Bridge Road NW to 14<sup>th</sup> Avenue NW and then to 115<sup>th</sup> Street NW. A formal detour route and associated signage will not be erected to mark the detour route.

The Rochester School Bus Service has been notified of the roadway closure and has been asked to reroute buses around construction to serve residents impacted by construction. Questions about Rochester school bus routes and stops can be emailed to Michael Pearse at michael.pearse@firstgroup.com

 A roadway closure of 2<sup>nd</sup> Avenue SE at 7<sup>th</sup> Street SE / Timberline Drive will occur on June 6<sup>th</sup> and will last for one day. The road closure is necessary to allow for the installation of watermain under 2<sup>nd</sup> Avenue SE to serve Timberline Drive.


During the 2<sup>nd</sup> Avenue SE roadway closure, residents are asked to detour around the construction and via 5<sup>th</sup> Street SE and Minnesota Avenue South. A formal detour route and associated signage will not be erected to mark the detour route.
